To help users target a specific time when searching for specific trips, the new transport search form allows performing a search using very specific departure or return times.

Certain carriers, such as Trainline in the United Kingdom, only provide a limited number of results per search (approximately 5 trains). On the journeys which have many trains departing per hour (every 5-10 minutes), only a few of these trains are retrieved and appear in the search results. This change allows users to search for trains which match their criteria.





[NEO] PRICE-CHANGE TOLERANCE ADDED AT TIME OF BOOKING

SYNOPSIS

Occasionally a user may select a fare during the booking process that is no longer available when the traveler begins the check-out process. To control costs and avoid bookings with significant price discrepancies, the new price change tolerance feature is now available.

The price change tolerance is an amount which is expressed in percentages. If activated at the time of booking, the following will be reflected:

- If there is a price change below a certain percentage, there will be no change. The user will be warned of the increased price at the last step of the checkout, and the booking is then completed.
- If there is a price change that is over the amount configured by the price change tolerance, the trip will automatically be canceled regardless of fare flexibility.

Examples:

- When booking a flight from an airline (GDS), a rental car or hotel, if the price increase is over the tolerance defined in the travel policy the entire trip will be canceled
 - **NOTE**: If the user books transport that triggers cancelation due to this tolerance being exceeded, and they had also booked a pre-paid/advance purchase penalty hotel or car booking, that penalty will likely still apply.
- When booking a service that is either instant purchase or non-refundable, services will be canceled, and penalties may be applied.
- Following the cancelation of the trip, the traveler and the arranger (if applicable) will receive separate emails which include:
 - Booking confirmation
 - Cancelation email

NOTE: Void will still be processed if activated.

WHAT'S NEXT?

Further improvements are expected in a future release on the following:

- User messaging to improve the understand of the user is currently being investigated, and the user flow will be improved as a consequence of these findings.
- User email flow is expected in a future version of Neo.





SCOPE

Limitations

- The tolerance will be applicable during the initial booking.
- Cancelations must be activated and supported in Admin Suite.
- This is applicable for any supplier, and any fares and rate types (non-refundable with or without penalties, low-cost carriers, instant purchase carriers...). If a user books from a low cost or instant purchase carrier, even if the feature is activated, it may be too late, and the payment may be processed.

OUT OF SCOPE

If an existing booking is modified, the tolerance will not be applied.

Users will now be able to inform car rental agencies about a particular request, such as a second driver or specific car transmission, a new feature will allow users to specify their requests in a comment field. Information in this field will then be transmitted to car rental agencies at the time of booking.

SYNOPSIS

Neo will implement a new Amtrak API, which is provided through connecting with SilverRail. This migration took place on 26 June 2024.

The following fare offers will now become available in Neo:

- Flexible: these fares are refundable and modifiable free of charge
- Value and Sales: Fares are refundable with an additional charge. It is not possible to modify the journey.

Users must now also provide their date of birth. It will also be necessary for users to agree to Amtrak's terms and conditions by ticking a checkbox which appears on the user interface during the booking flow:

SYNOPSIS

As part of implementing the new Trainline API and the RDG accreditation, Neo has improved the message displayed to users during a partial cancelation by displaying the message if part of the trip has not been canceled.

If a traveler cancels a Trainline ticket and not all legs have been successfully canceled, users will now see the following error message:

"Your cancelation has been partially made according to the travel policy of the fare(s) booked. To see if your tickets that have not been refunded, please logout and then login again."

SCOPE

This message will be displayed when travelers cancel a Trainline trip, and when at least one of the legs of this trip is not refundable nor able to be canceled.




Previously when a hotel's name contained more than a certain number of characters, the name of the hotel would not be fully displayed.

For clarity, users will now be able to see the entire name of the hotel since the number of characters has been increased in the field HotelName.

SYNOPSIS

The American Express card transactions feed will frequently include duplicates of transactions which causes confusion at the time of import. To avoid issues linked to these duplications, the duplicated Amex transactions will be ignored and no longer imported.

This behavior has already been put in place for Mastercard 'cdf3' import format and has now been extended to American Express card transactions.

SYNOPSIS

A new audit rule based on the custom field (closed list type) values has been implemented to provide customers with a more complete list of rules to configure.

When an expense report is submitted with at least one expense line containing a specific value in the custom closed list field, configured in the audit rule, the audit rule is triggered, and the expense report is sent to the accountant for manual review.

REMINDER: For this to be configured, the expense report workflow must be set to one of the following:

- Audit, Accounting agreement then supervision
- Supervision then Audit and accounting agreement





[EXPENSE] COMPLIANCY WITH ISO 4217 ON CURRENCIES AND DECIMALS

SYNOPSIS

The ISO 4217 rule defines the number of decimals authorized per currency. To comply with this rule, from Neo 24.3 the following currencies will be changed to 0-decimal currencies:

Currencies not mentioned in this list will remain as they are at present, i.e. with two decimals.

JPY, KRW and VND currencies are displayed with 0 decimal in Neo.

The TWD currency will be changed from 0 to 2 decimals in order to be compliant with the ISO 4217 rule.
